






punctures the moment of innocence there is a forever lost dissonance.





THE DIFFERENT TYPES OF CANNABIS

The future is looking greener with the rise of hemp – the sustainable crop that's making waves in fashion, food, and beyond.

With a growing demand for sustainable energy sources, hemp biomass is becoming an increasingly important part of the natural energy landscape and as more research is conducted on the potential benefits of hemp, it is likely that we will see even more innovative uses for this remarkable plant's by-product in the future.

Cannabis is a plant genus comprising of three primary species: Cannabis sativa, Cannabis indica, and Cannabis ruderalis.

Cannabis sativa is typically a taller plant with thin leaves and longer flowering cycles, making it better suited for outdoor growing in warmer climates. It tends to have higher THC content and a more uplifting, cerebral effect, making it ideal for treating depression, ADD/ADHD and fatigue.

Cannabis indica, on the other hand, is usually a shorter, bushier plant with wider leaves and shorter flowering cycles, making it better suited for indoor growing. It tends to have higher CBD content and is known for its sedative effects and can be effective in treating conditions like anxiety, insomnia, and chronic pain. Cannabis ruderalis is a smaller, hardier plant with a shorter flowering cycle and is often used for breeding purposes due to its auto-flowering trait. It is typically low in THC and other cannabinoids, making it less desirable for medicinal use on its own.

Different strains of cannabis plants, including those used for hemp, have different growth patterns and requirements. Hemp is characterized by its low THC content (less than 0.3%) and high levels of CBD, and is specifically bred to produce these characteristics. Hemp is typically grown in rows, with the plant spacing dependant on the desired outcome. The optimal climate for growing hemp is in temperatures between 15-27 degrees Celsius with plenty of sunlight. Hemp requires less water, pesticides, and fertilizer than many other crops. On average, a hemp plant takes between 70 - 140 days to reach maturity. Not a very long period, considering the vast applications of the plant.

Hemp biomass is all the plant material that is produced from the stalk, leaves and flower of the hemp cannabis plant and so hemp is therefore a highly sustainable crop. The preferred variety used to produce hemp is the Cannabis sativa plant, because of its versatility and growth. The interesting part about her growth is the aim of your application – if it is to get biomass for hempcrete or fibres for clothing and rope, you'd plant them close to each other, so they stretch for the sun and become tall and skinny.

If you're after seed or high CBD flower, you would plant them spaced further apart, much the same way as you would conventional cannabis plants for recreational purposes.

Hemp is also commonly used for industrial purposes such as textiles, paper, and bioplastics, with ongoing research to investigate the vast potential applications of hemp biomass, including the production of fuel from its biomass. Hemp biodiesel is made from pressed hemp seed oil; and hemp ethanol/methanol is produced from the fermented stalk of the plant. As it is extremely cost efficient and easy to extract, it is a truly sustainable fuel option for the future.

Research has also shown that hemp's biomass can be useful in reducing greenhouse gas emissions and improving soil quality. Hemp can also be used to clean up contaminated soil through a process called phytoremediation. This makes it an accumulator, and these plants should be processed accordingly.

Hempis also an alternative to traditional livestock feed – it is high in protein and can be used to feed animals such as cows, pigs, horses and chickens. This not only provides a more sustainable source of feed, but also reduces the environmental impact of traditional livestock farming. Her biomass also contributes as a human food source, in the form of seed. Hemp seeds are highly nutritious – rich in protein, fibre, and essential fatty acids and can be used to make hemp milk, oil, and butter; and hemp protein powder is a popular supplement used by athletes and health enthusiasts.

With fewer options of decorticators and other machinery required to process the actual fibres than many other countries, we still need to invest a lot of time and capital to find an African solution to this African problem. As it currently stands, it can be difficult and expensive to harvest and process, particularly for fibre and seed production.

With legislation still neither here nor there, getting farmers to apply the practices of hemp farming is a major obstacle we face in SA. Another hindrance is the acquiring of seeds and the fact that once seeds have been successfully obtained, cross pollination from other hemp grows pose a relatively large risk. This is why hemp grows need to be planned, monitored and executed responsibly.

Hemp has the potential to bring people together by promoting environmental sustainability, economic prosperity, as well as health and wellness. By supporting the use of hemp-based products and practices, we can all worktowards a brighter future for ourselves and our planet.







Who is "Nongo" and how did you get into the cannabis industry?

I am an ex-Military Pilot from the then Bophuthatswana Defence Force. I am also a fashion designer and studied Apparel Product Development from Sew Africa in the Jo'burg Fashion District. But most importantly, I am a socio-economic and cannabis activist. My first encounter with the cannabis/hemp industry was when I was invited by Dr.Sunshine Blouw from the CSIR to attend the 2002 World Summit on Sustainable Development where they were discussing a paper on the Application of Natural Plant Fibres. That is where I first met Tony Budden, the Godfather of Hemp.

How long have you been in the hemp industry and has it grown much, since your initial involvement?

I have been in the Cannabis/Hemp industry for over two decades now. The industry is steadily gaining momentum, especially since the Zondo ruling in 2019 which resulted in the first hemp permits being issued by SAHPRA and now DALLRD.

The President has also put the spotlight on the industry in three of his State of the Nation's addresses.

Have you, as an individual, been able to sustain people working for you in this industry?

Even though I have been through difficult times and challenges, I have still been able to provide 10 sustainable jobs thus far, with future employment opportunities being imminent.

What role do you see hemp playing in South African's future?

With proper enabling legislative framework and inclusivity, the Cannabis industry has the potential to address the triple challenges of poverty, job creation and unemployment.

What has the growing process of the plant as well as the Cannabis plant herself, taught you as an individual - from a physical, spiritual or mental perspective?

The Teacher Plant Cannabis, has taught me that she needs to call you first. She has taught me that the human race needs to have respect towards mother earth. To practice love, sharing and happiness. It has also revealed itself as a unifier and has no boundaries in terms of colour or race.



Can you tell us what projects you are currently busy with?

At present, I am busy with a hemp pilot project for the North West called Nongo's Joint, with Druids' Garden as our implementation partners and with support from Small Enterprise Development Agency (SEDA), the Ngaka Modiri Molema District Municipality and the North West Department of Agriculture.

I am also busy with the 420 Tribe Social Club, in collaboration with Grow one Africa – a community driven initiative for educational and awareness drives, which aims to raise funding for community development projects.

I am also involved with Africa Farmers Association of South Africa (AFASA) as both the National Deputy Chairperson and the North West Provincial Chair for the Cannabis Commodity.

I also serve as a chairperson for the Cannabis Development Cooperative of the North West.

I travel around the country, stopping off in different provinces, engaging and educating youth and women on cannabis harm reduction and instilling entrepreneurship spirit within the communities for future sustainable development.

In a perfect world, how would you ideally like to see the human race and the hemp plant serve one another, to be mutually beneficial to both species?

Well, I would like to see the human race acknowledging the intelligence of this teacher plant and appreciate the fact that we can be one with the plant. We live, breath and heal because of this plant. So, the best thing we can do is to support the growth and use of this magical plant to make Mother Earth green again in order to benefit us all.
