The outcomes to that end were a bail term with the highlights of a "joint agreement"; the pun in the coinage. Reflections of mutual intent to allow the transitioning of legal frameworks towards the partial freeing of the cannabis plant; the same privileges that in interpterion are transforming the province of KwaZulu Natal (KZN) into a modern-day Kathmandu, over three hundred shops are reported to have opened their doors to the masses towards responsible and private adult use.

## ABALIMI BOMYA CONSOLIDATE TOWARDS EXTERNAL ENGAGEMENTS

Organise and Formalise, a call to the realisation of oneness found as the loss of the attributes formed by illusionary divisive percepts fall away; realizations in separation that not only crippled the desires of the heart but in swinging rippled the power of the masses to sole centers. The call to gather in Sandboxes, in Green Networks, in Centers of **Spirituality and the Lean Net** worth circles is one such model that in numbers and systematized functionality is presenting points of reference in consideration of the cannabis plant potentials and privileges. These can lobby policy makers and governmental reach with present actualities in practice that relay the directional functionality found on varying circles of the Cannabis plant in this framework. One such thrust in organizing and formalizing to the systematic status quo has seen ABALIMI **BOMYA gather in Port St. Johns** Eluxolweni under the tagline of a Founding Summit. The gathering witnessed the physical representation in the heritage represented by the Cannabis plant as farmers from across the **Cannabis belt in the Eastern Cape** province gathered at the summit presenting a pathway to free the uMya plant.

The two-day gathering saw cannabis growers from Winnie Madikizela-mandela, King Sabata Dalindyebo, Ingquza Hill, Ntabankulu, Nyandeni, Port St Johns and Mhlontlo local municipalities converge at Eluxolweni.

The founding summit ran for two days between the 12th and 13th of October on a consolidative front considering routes and models of application towards coupling into the proposed commercial cannabis conduits with consideration of addressing the crippling legal frameworks in the presence of absence thereto. The pre-existing cannabis grow community and native economy of the herb in the present-day **Eastern Cape lands is** documented as far back as the 1600AD. These narrations position the commercialisation discussions from the government as playing catch up to the Cannabis systems natively reeling across the Pondoland bedrock. It is such that even in the proposed rolling out, mutual intents are being relayed to not only find middle ground between the old and the new but to birth channels of actualisation mutually balancing to both parties.

In appropriation with a founding summit a leadership structure was formulated as an organizational point of reference to steer functionality towards the realisation of a multi-generational call to free the plant whilst filtering the internal external communication. In discussion after the Summit Mpondoland **Cannabis Belt secretary Snoux** Poswa relayed the primary benefits aligned with Cannabis indicating that money and influence were part of the privileges provided by the Cannabis plant stating that "the first benefit is money, the second benefit is influence and the third benefit is increasing economic activity". **Benefits from the Cannabis** plant that have been a present reality for the Eastern Cape **Cannabis belt community for** generations in time and advantage that promises to ping the region as a powerhouse when the green economy goes online, never minding the indigenous knowledge yielding the 1:1 THC, CBD cannabis flower. Now if a similar approach in balance could be the melody of the policy makers, then victories for the plant are assured as only division and unequal attribution can be the cause of collapse among the organised and the formalized.

The experience was definitely one for the red eyed day in the stoner calendars; the winners of the 5th edition of the Amber Cup witnessed the power in collaboration as the combination in Amadeadly & Green Squirrel took the top spot for an overall bliss encounter. In issuing the welcome remarks Joane Perry of Fields of Green For All spoke to the present participating judges indicating the protocols and procedure to "dab small quantities so as to allow room for all the 13 participating dab opportunities". The second place was awarded to the dab of Fire & Ice who kept the balance in the hot and cold coming ahead of Medusa Dabs who completed the top three. This 5th edition brought a twist to the plot as considerations on the aesthetics found a rewarding return, an accolade which was awarded to Highable. XKanna spoke to Amy Case King as she partook on the dab from Kris and G-nome garden; "i did three separate temperatures, which was a nice incremental blast because each terpene offers a little bit more"

The Amber Cup gathering is synonymous with Cannabis connoisseurs and the relay in the dab execution spoke of ascension to high class Puffco rigs and a dab along addons. Wesley Y of Bio Leaf danced with the B's stating that "every year it gets bigger and better and that's what's happening with the industry. Every year I know there are hard knocks and we take a couple of steps back but every year we are moving forward". An initiative headlined as a call for applications towards IKS **Cannabis Permits has been** rolled out with a target to actualise the first grow this **December Hemp planting** season. The call to partake in the cannabis sandbox is a collaboration seen in the assembly of the IKS Center and the School of Agricultural Science at North West **University** joining hands with the Ras-Tafari Nations; **Traditional Healers Organisations**, Marijuana Board **Of South Africa together with** Indigenous farmers under the support of the Traditional leaders.

In a discussion on PlantX Radio the Cannabis Queen of the South Dr. Thandeka Kunene put forward the foundational frameworks of the IKS Sandbox initiative stating that, "we have put together with the University of the North West an IKS Sandbox Commercial Research study". The opportunity talks to allowing people to get assisted **IKS endorsement that attaches** to the government issued Hemp permit.





The facilitation is in this moment providing a door way of access for applicants through intents that have seen the facilitators bear the burdens of the benjamins in the rolling out of consultative services. A blueprint that answers questions to interested parties seeking the starting point on the journey of participation in the mainlining of the Cannabis industry. "We are offering our **communities free Hemp** application form checking, as we assess for submission readiness"; a procedure that positions towards the acceleration of the governmental department's turnaround time. The indications talk to intents of reaching peak periods of four weeks with aided filtering from the facilitation afforded in this Sandbox. Talking to the continuation from permit to farm and the end game in the box of sand Dr.

Thandeka Kunene points to end user sureties in reference to standing agreements. "We have secured three main offtakes, one for fiber, one for seed and one for CO2".

On the weekly online Zoom gatherings, the indications have pointed out the primary thrust of the IKS towards the goal of unlocking the Insangu IKS grow permits and seeing the first grows seed to life this **December.** Some of the solutions presented as being afforded by the Intsangu IKS permits Indicate that the **Cannabis Sandbox will see** facilitation ranging from seed supply to offtake and value addition routes for the biomass. The IKS Sandbox call closed the first batch of Cannabis application submissions on the 21st of this month with promises and presentations talking to points of entry into the cannabis industry. This through the linking of eased protocols in compliance in considering of different THC graded cannabis grow opportunities. Access to synergised societies that sequences to see the seeding of Sensimilla among commons without the big capital stock and a hemp initiative talking to helping interested parties find a place among indigenous cannabis strains and knowledge systems

## **RASTA CONTINUE FIGHT FOR HERB ASSOCIATION**

The worst in the gun war on Cannabis is indicated as over, well state to the people one would say, this steering away from the green turf wars and the plant geographical foes. The present plains of South Africa is seeing talks lean towards a penned policy change in indications that the aftermath in the war that has been synonymous with the anti-Rasta <mark>campa</mark>igns has changed battlefronts. From the banning of reggae music to the stigma in the dreaded locks, Ras Thau Thau indicates that the fight in resistance has informed his life in entirety even with considerations to the fact that in his living history as a Rasta the primary mandates that have been informing even the discussions around his existence have been a fight for the Freedoms of the cannabis plant.

**Speaking to PlantX RAdio on** Weed Wednesday Dacha **Discussions Ras Thau Thau** indicates that there has been a change since the policy engagements that happened in June this year in Pretoria under the banner of the Cannabis and Hemp Phakisa Action Lab. The post engagements are a watershed moment that even in the modern-day terminologies and discussions the references to the gatherings are classified as a bold step of intent, when talking to the enabling of wheels of the cannabis industry and shadow halting arrests for privacy in the Cannabis personal association privileges. The government and the Cannabis **Steering Committee have** seemingly been stirring the Dacha waters in a bid to unlock the Cannabis plant economy whilst roping in the legacy cannabis communities.

The change in the fight has shifted in trajectory as ideologies and practicalities presented as the route way to the free plant have mounted antagonistically as gatekeeping processes blocking pathways for participating in the cannabis industry. The requirements which arrive on the battle front as modern day opposers to the Rasta and the **Cannabis plant; in reference speak to** protocols that are slowing the participating opportunities for the **Rasta nation.** Appropriations in provisions to which Ras Thau Thau remarks stating that, "the facilities that are required we still find them to be quite anti-Rasta, as Rasta we know that, this plant we have been planting it whichever way and anywhere. We never had all of these snobbish ideas now that government is coming up with that you must have some facilities and you must have electric fence, you must have cameras, you must then have plus R25000 for the license and have a facility that will cost plus minus three million rand."

**These provisional Cannabis** grow guidelines that emerge as poles of the new fight that has shifted in technicality yet the core and the essence remain the primary base that hinders access and inclusion of the Rasta within the Cannabis plant privileges. Desires and calls of participation that still in the present day have not disappeared from the hearts of the Rasta nation. The pursuit towards these liberties once again present another battle front and a reality in the fights facing the Rasta; "We are still fighting these Eurocentric impositions, but as we are fighting those things for the past five years since Zondo ruling, people who never fight for Cannabis, who never marched on the streets for Cannabis particularly the Europeans living in South Africa and the Indians have benefited a lot and continue to benefit a lot...whilst the people Rastafari, who are historically stigmatized with cannabis are left out". This he says further indicating the ownership disparity witnessed in the demographics of the four hundred plus Cannabis shops that have opened their doors in

participation towards grasping of the Cannabis plant privileges. The current discussions of interest to the Rastafari nation enforced by the presence of the community leaders and representative bodies are considering models such as the Indigenous Knowledge Systems sandbox. Initiatives through which penned policies and presented frameworks point to innovation in practicality looking to lower the entry procedures towards participation in the Cannabis industry.

The turning of the times remain to be the provider in responses as XKanna continues to ask. Will the Rasta nation find a home in this current cannabis movement? Will the Ganja plant find a home in Jahs house without the barriers of the **billions?** Will the plant policies in formulation mold bridges towards the inclusion for the legacy communities that have generationally paid the price for the presence of the plant? Maybe a policy Pen fight will tell but for now at least, in South Africa its guns down and pens up.



# **GALOWS THE HOMECOMING OF GREEN GOLD TO BERGVILLE**

As the Cannabis sun shines over the mountains of Bergville, the sounds of the winds whistle a new song at the sight of the returning cannabis plantations, a returning of the plants founded on the homing of the spirits and the repatriation of the physical remains of the Ngoba twenty-two. As the gallows exhumation project was launched at the Kgosi Mampuru **II Correctional Centre in Pretoria**, the conversations anchored on the restoration of the dignity in burial and the cultural homing of the spirits of the deceased, this talking to the thousands who lost their lives to the gallows at the prison. The Ngoba Twenty-two were Ngoba, **Bergville community and Cannabis farmers who in** response to a supposed attack on a community kraal collided in battle with state policy enforcers looking to raid the village Cannabis grows. The year was 1957 and the exchange in the fight to defend the crops witnessed the loss of lives of five branch police officers and of two Ngoba Cannabis Farmers. The subsequent year unfolded in the trial and the hanging of the twenty-two farmers from Bergville, Ngoba village at the **Kgosi Mampuru II Correctional Centre. Following years without** customary affiliation the spirits of the twenty-two look to have found rest following exhumation and repatriation efforts rolled out by the Local Municipality.

# **GALLOWS TO THE GARDEN** THE HOMECOMING OF GREEN GOLD TO BERGVILLE

The primary government body has taken a bid to unlock the Cannabis economy on the Drakensburg foothills and open the doors to produce cannabis officially from the land. This initiative has been exemplified through Cannabis plantations and the rolling out if definite intents to redirect the cannabis narrative in the Bergville community. The healing of the hearts in the repatriation of the Spirits of the twenty-two cannabis farmers has formulated a spiritual foundation in the restoration of the Cannabis plant freedoms through a formidable synergy in lives shared and exchanged between the Ngoba Twenty-Two and the Insangu plant. It is on these foundations that the first harvests were reported earlier this year by the Okhahlamba Local **Municipality Mayor Vikizitha** Mlotshwa who gave an overview of the Emaswazini pilot project indicative of initial success, learning pathways and growth opportunities. The expansion references stating that "all three traditional leaders (amakhosi) under their jurisdiction have been granted a license to collect dagga from people and send it to a factory located near the town of Winterton". 


## **JACQUI RAMAGE ON CANCER & CANNABIS**

### VERB ANONYMOUS: FEEDING HOPE, WITH MUSIC




Verb Anonymous whilst speaking on PlantX Radio indicated that "the life options presented to the young people in the Newclare, Westbury community boarders around two worlds; school or the streets". In the aftermath swinging between the gangster and academic options, Miscellaneous studio has created an outlet for the young people of Westbury to not only find a platform for actualisation in melodies but for a potential pathway to emotional expressions and economic freedom via music.

One of the artists that forms part of the gang at Miscellaneous Records is Kid Loner 47, a twentyyear-old Hip Hop artist who after completing his high school studies last year has found expression musically. The three years of his affiliation with the record company has seen the composition of his lyrical lines landing on tracks talking to Corruption and **Running the Block in narration of** the present challenges in the Newclare community. His remarks on the dynamics of his community synergise with those of his mentor as he states that "here in Newclare people have tried to get along but chaotic things are happening so that people don't get along together and when they happen people lose their minds and hope. Its kind of hard for people to actually find hope here, so what I am trying to do is through music find a job, feed fam and go with the community like spread hope and speak peace. A stoner in his own right Verb speaks on the herb and the roles that Cannabis plays in his life and the curation pathway stating that "I have smoked Marijuana since my first year of high school but I have never tried drugs,

it never made me do no crime I never killed anyone". In reference to the balance afforded by the plant when in the booth with the beats Verb states that "I definitely draw inspiration from the herb when I smoke".

The freedoms that music has presented for a people across revolutionary journeys has been coded on numerous books and hooks talking rags to riches across different lifetimes. From the riverside Zion redemption calls to the rallies for war; music has massaged the soul in messages reaching where no hand mercenarily touches. Whilst Verb Anonymous story looks to the community in Newclare the challenges experienced in these spaces are synonymous with the present-day realities in numerous communities across South Africa. Unless intentional intrusions are injected to change the narrative such as the mandate of Miscellaneous Records, the plight of the people in these communities, the pangs and the bangs of the firearms will continue to be the melodies in songs of sorrow.

Johannesburg is a cause that has become an everyday melody on the lips of residents within the community. The intensity of the crime in the area has earlier in the year witnessed the SAPS prioritise the crime ridden area as the ministry held a Ministerial Crime Prevention Imbizo at Westbury Recreational Hall in the community. Waking up to news and sights of the deceased in the area is the buttering of the bitter bread realities faced by the residents in the community. 


