

THE LIFE CYCLE OF THE CANNABIS PLANT

CANNABIS SATIVA L. IS A HERBACEOUS PLANT BELONGING TO THE CANNABIS GENUS, FAMILY OF CANNABACEAE

Every gardener or plant lover can attest to the sheer joy that manifests itself, when a seed you have sown, finally germinates. The next happy dance occurs when your plant graces you with a new leaf.

The beauty and pleasure of watching a plant mature from seed, is possibly one of the greatest gifts bestowed upon humans. Watching a cannabis plant mature, is nothing short of perfection.



I think in 2023, it's safe to say that we have all been exposed to cannabis or cannabis products at some point.

Whether sharing Mary Jane with close friends, or buying CBD capsules, tinctures or teas – our world has progressed in such a manner that the essence of this plant is more appreciated now more than ever before

This majestic plant has proven time and time again what amazing healing properties she possesses and why our elders used her as medicine in their daily practices and why there is ongoing research into her healing components.

Many of us, when buying any herbal product, do not understand the forces that supported the growth,

The first thing to understand is the difference between a perennial and an annual plant.

In basic terms, a perennial plant lives year after year, whereas an annual plant goes through its entire life cycle within one year. Cannabis is a perennial plant.

Nutrition plays a very important role in any plant's growth. In cannabis growth specifically, Potassium, Nitrogen and Phosphorus are key nutrients for optimal growth at different stages of the life cycle.

The life cycle of a cannabis plant comprises of four stages, germination, seedling, vegetative stage and flowering stage.

Germination – this is the sprouting of the seed, and where two very important factors play a role both with the occurrence of the splitting of the seed.

Once the seed's seem splits, a root (tendril) will rapidly grow and move downward through the soil until it is deep enough to support the rest of the plant.

The husk now splits and the plant emerges from the soil, where two leaves will appear that act as a biological solar system to absorb enough energy to start the plant's chlorophyl production.

The germination process can take anything from 24 hours to two weeks, and this is also determined by genetic composition and environmental factors.

Seedling stage – (and possibly one of the most jaw clenching stages of any plant growth) your plant is now a baby and has two leaves that are completely different to all future leaves produced.

Shortly after germination, your shoots, known as sucker leaves, will produce two-lobed leaves, from the centre. After the two-lobed, comes three-lobed, five-lobed, and then the most recognizable seven-lobed cannabis leaf

Now, seedlings also start to develop a stronger rooting system which allows for optimal nutritional intake.

Depending on environmental factors the seedling stage can last anything between two to six weeks.

Vegetative stage – or, where life begins. This stage is all about growth, trimming and training.

If the cannabis plant goes through a good vegetative stage, it will go through a good flowering stage.

During this period your plant will need more nutrients to support new foliage and a healthy, strong structure, to bear the weight of heavy buds.

There are a few key factors for a successful vegetative period, namely Light, Temperature, Humidity and Watering, to name a few. At this stage, the plant will grow as many leaves as possible, to gather more sunlight that it may convert into energy.

Vegetative cannabis plants thrive under 18 hours of light and 6 hours darkness and the light enables the plant to make food through photosynthesis.

Photosynthesis has three key components: Energy; absorbed via the plant's leaves, water - absorbed via the plant's roots; and carbon dioxide - absorbed via air.

Reproductive organs start to develop at this stage, and this is generally when you start to look out for pollen sacks – a topic we will cover in another issue.

The vegetative stage can last anything between 3 to 16 weeks depending on genetics and the environment that the plant is being grown.

Your plant will come out of vegetative stage, once she received less light, because she is a photoperiodic plant.

Flowering stage – This is the final and most rewarding stage of the cannabis' life cycle. This stage lasts an average of 7-9 weeks, but once again is determined by genetics and environment.

During the first week of this cycle, the plant produces intense veg-like growth, and can sometimes double it's growth, to prepare itself to bear the weight of the buds.

During the first two weeks, the difference between female and male plants become noticeably different.

The female plants are what you are looking for, for the growth of flowers.

Male plants produce pollen sacks, and if they pollinate a female plant, they turn the bud sites into pods, to produce more seeds, instead of trichome (small resin glands on flowers) rich flowers.

It is of the utmost importance to discard male plants, if you are specifically growing for flower production.

At the flowering stage, the female pistil hairs (female plants have oval shaped leaves, with white pistil hairs) start layering up and form buds.


The cannabis flower consists of three parts, pistils, sugar leaves and trichomes.

Trichomes have the highest concentration of cannabinoids. Sugar leaves also contain cannabinoids, but not as significant as trichomes.

As the cannabis plant gets closer to the harvesting period, you can keep a close eye on the trichomes.

Cloudy trichomes have the most THC.

You will also notice the fan leaves starting to change colour. Fan leaves will start to turn yellow and fall off as nitrogen decreases.



The fan leaves may potentially also curl and dry, as the plant takes in less water when she gets closer to the harvesting stage.

There is no doubt that once your plant has reached harvesting stage – there is cause for celebration.

How magical, that by nurturing her growth, she rewards you with the most beautiful flower, that in return, nurtures you.

Once harvested, your bud may serve you in various ways, depending on your relationship with her, and what your needs are.

She is medicine, she is a teacher, she is quiet in the chaos, and so much more.

Cannabis growth, like everything in life, will thrive, if nurtured.

Every leaf that grows will tell you: what you sow will bear fruit, so if you have any sense my friend, don't plant anything but Love."

GROW ONE AFRICA'S DIRECTOR, KOBUS SCHOEMAN, GIVES US THE DOWNLOW ON WHAT GOA ACTUALLY DOES, WHAT IT MEANS TO BE A COMPLIANT CULTIVATOR AND HOW CANNABIS CAN PLAY A PART IN HELPING TO BUILD A SUSTAINABLE GREEN ECONOMY.

How did GOA come about?

My wife, Daleen, and I started our journey in the cannabis industry in December 2018 when we opened our doors as Canapax in Oudtshoorn, the second of many of these shops to open across the country. It lasted all of three months before we realised that our proposed model and that of Canapax was vastly different and so, we closed our doors and approached the National Prosecuting Authority to seek clarity on the legality of our club structure. After waiting two months and getting a "we can't comment on the legality" response, we opened our doors as One Culture. This was another great learning experience and a year later, and as soon as the High Court confirmed that our vision and that of our partners were contradicting, we once again stepped aside and started over. These first 18 months of our cannarollercoaster-ride had garnered a lot of attention from friends across the country and by the time we started trading as GROW one AFRICA, in June 2020, we had a whole army of eager cannapreneurs lined up and ready to get the industry rolling. We started the GOA journey with 4 independent clubs opening their doors on the same day: Die Boomhuis, Die Joint, The Toke House and Tiny Town.

Grow one Africa is a Cannabis Social Club Regulatory Company - What does this mean? What does GOA do?

GOA fills the void left due to the lack of legislation and standards to govern our industry by offering self-regulating compliance measures, setting standards and formulating standard operating procedures for clubs and their members to follow. Although we are not an official government entity, we have developed a cannabis club model that we share freely with anyone interested to start their own and offer systems and apps for clubs, cultivating- and processing members to track and trace and manage their cultivation, processing and club operations. On a day-to-day basis our team helps clubs and cultivators complete their compliance submissions and issues them with reports on their compliance to the model. Our system facilitates the contracts and administration between members and clubs and is also used to calculate reimbursements. Further we do monthly financial compliance audits on clubs, process and pay cultivating- and processing member salaries, pay all associated taxes and issue IRP5's. Participation in the self-regulating model is voluntary and GOA ensures that everyone follows the code of conduct, rules and regulations.



How did you conceptualise the GOA model? Where did you begin?

Although we could learn a lot from international examples, such as the Spanish and Uruguay club models, the starting point was the constitutional ruling that decriminalised cannabis in SA and confirmed our constitutional rights. Months of studying the ruling and relevant legislation, heavily assisted with cannabis, lead to appointments with various legal experts and discussions with industry players; all contributing to the model taking shape. We adapted international and local standards like GAP, GMP, ISO and SANS to formulate a model that offers African solutions for African problems. Finally, we put it all together using Permaculture (Permaculture is an approach to land management and settlement design that adopts arrangements observed in flourishing natural ecosystems) as a design science to give it structure and ensure sustainability.

There seem to be a lot of cannabis clubs popping up all over the place. What are your feelings on this?

The more the merrier! I think that cannabis clubs are great awareness centres that help break the stigma associated with the plant and bring together like-minded individuals that want to contribute to their community. As long as clubs can ensure the safety and quality of their offering and they are busy setting standards and not taking chances, there is definitely a place for them. I will encourage anyone that wants to open a club to do it but be authentic in what you bring to the table, and remember to be yourself because everyone else is already taken!

It's quite a mission to open up a GOA club. Why have you got such strict club compliance measures in place?

I always say that the solution is in the problem. And the problem here is the lack of legislation or official structure for our industry. That is why we chose the solution of overregulating ourselves in this time of legislative lacuna, or gap in law. There was no bar, so we set it as high as we could. We can always relax our compliance measures once policy makers catch up, but it would be difficult to implement those measures only once given to us by the government. The real mission is to realise that cannabis is like any other industry and in order to take part you must comply with various laws, municipal by-laws, company regulations and SARS

to name but a few. The strict compliance measures are aimed at giving clubs and their members a defensible argument for what they are doing and in my opinion some paperwork beats sleeping on a concrete floor every day of the week.

Why would someone choose to open a GOA Club?

GOA is a family, and the same as any other family, you must do your homework and decide whether you want to marry into it. We are strict and we expect all our family members to intently adhere to the self-regulating model and standards set by GOA. We enforce our code of conduct and clubs and members can, and have been in the past, expelled from the voluntary group. The family also offers new clubs an instant community of like minded members that can visit their sister clubs and offer valuable insight into the culture and the industry. We are the original service provider to cannabis clubs in SA and the GOA family is the biggest of all the organised groups of clubs in the country, and still growing. So I guess if you want to do it right, do it with us!





How many GOA clubs are there?

Today we offer services to 22 independent clubs, with 7000 members, 130 cultivating and processing members in the GOA family that employs 1200 people currently.

Can anyone go visit one of these clubs?

Only adults are allowed, some clubs have an age limit of 18 and others 21. Make sure to check our website for details of the club nearest you. www.growone.africa

How does one become a member?

Watch a video online that explains what GOA does, select the club you want to join, answer a few questions to confirm you understand the model and complete a needs assessment to determine how much cannabis you require from the club. Once approved by the committee, go to your club to have your ID verified, selfie photo taken, signature captured and to pay your initial membership. The application and verification process takes 10 minutes and the monthly memberships are very affordable.

What are the benefits of being a GOA club member?

You will have a safe designated clubhouse to hang out with other GOA members and have access to safe, responsibly cultivated and processed cannabis products while supporting members of your own community. This means you can self-medicate or use cannabis recreationally, culturally or religiously while still being a responsible citizen and contributing to the fiscus through the associated taxes paid. These ego-free zones encourage meaningful conversations and various businesses and personal relationships have been forged at these clubs. Also remember that valid members can visit any one of the GOA clubs across the country.

I bet you get this question a lot - I think I grow some pretty good cannabis. Can I become a cultivator for GOA?

You're right, this is quite common, funny though that the samples they bring you is never the best that they have grown before! The beauty of this system is that it is accessible to everyone, and although not everyone turns out to be a master grower, they can still get the opportunity to try their hand at it. Link in with your club, attend the cultivation and processing workshops, sharpen up your skills, get acquainted with the GOA SOPs and requirements and most importantly build a relationship with your club's compliance officer that will assist you in creating a cultivation/processing plan. These are matched up with the member needs assessment and if you meet the grade you will be supplying your fellow club members' demand in no time.

What role would you ideally like to see cannabis play in the South African and African economy?

I see cannabis as the spearhead crop that will unlock plant wealth in Africa. It is a sacred plant and the common denominator bringing together all tribes on our continent. It is our duty, through industrialisation, to give cannabis its rightful place as a superfood, powerful medicine, a sacred sacrament and an industrial wonder product. It is up to us to make the next 10 years green, a thriving green economy for a thriving green Africa, growing its own future!

Tamara Thomas on the same publication that "the proposed bill rethinking and we need to challenge government on that front as the proposed bill does not serve our purpose well". AFASA & CHEEBA, A CANNABIS LIGHT OF HOPE FOR YOUNG FARMERS

s formalities in structures and synergies unfold and tangle in the cannabis industry the fractals in formulation fiddle in sequences of spark that see a medley as flamboyant as Cheeba Cannabis College and AFASA (African Farmers Association of South Africa). KannaXpress crossed lines with Mxolisi Mthombeni the provincial chairperson of the AFASA youth in Mpumalanga as

well as Amy Ludidi on separate conversations as the flames to this tale came alight.

Mxolisi a seasoned grain farmer indicated that primarily the formulation of the AFASA cannabis commodity was in response to the farming opportunities on the forefront of the cannabis industry, the AFASA MP youth chair indicated that there is hope for young farmers as there are already season hemp farmers such as Dr. A Jamalooden who present support structures for young farmers. Relaying to the fire in the cooking heat and the toasting flames Mxolisi speaks of a ready framework from which to build upon, as he lines out activities and systems on the pipeline to the benefits of the youth as he states that "to assist them (young farmers) to start off and see this hemp and cannabis as a business which they can go for, because

like the soya and the grain which we are planting, cannabis can also be planted the same way, we just need to first master the skills of planting it. We haven't been in that field for a while so its just new ground for us and it's a great opportunity for young farmers to move onto".

With regard to the marriage of the new and the old in the emerging cannabis crop now calling for ground on the farming land Mxolisi indicates that the bridging system is the compromise that will wade in the tide of the cannabis plant in a feasible manner. "We need to first of all introduce this cannabis plant in an experimental state, as a crop rotation plant; If you come to Mthombeni and say stop doing your maize which is giving you money every year and grow cannabis, it might be very hard to crack that nut. He won't be able to bite up until you get to be with

him face to face and get to sell this cannabis commodity, also sell the plant as a solution to a lot of case problems because when we go down its no longer about the world but about the farmer. How will cannabis help him? How will cannabis change his life? What impact does it have on the soil? Then you will get a perfect marriage for the farmer". Amy Ludidi featured on the PlantXRadio Weed Wednesday channel and spoke of the innovations the Cannabis College has witnessed on their campus as they exit the CANNA DEN; we are bound by NDA but in principle these young academics are innovating amazing solutions addressing the bridges in the cannabis space as she remarked that "one of the things in the 12 week programme that we do at the end is a business pitch where the students pitch,...
