Rastafari Youth Farmers gathered in the Midrand town of Johannesburg in South Africa in a bid through an asset based approach to continue to equip and empower the Rastafari Yut to identify and use the tangible and intangible assets in the formulation and operation of cooperatives. The gathering was facilitated by Sadi Motsuenyane and Dr. Johannah Keikelame under the roof of House of Hemp South Africa. Daluxolo Kunene from House of Hemp Seven spoke to CannaXpress on the intention of the gatherings stating that "this has been our second workshop on such a thrust, we have had a workshop for women in farming, now with this Rastafari Youth in farming we are seeing a follow up event and we are looking to accommodate specialty groups such as Sangomas in farming also. The primary ethos of these workshops is to facilitate community building and income generations that talks to sustainability, we are aiming at uplifting communities through the workshops".

The three day workshop that ran from the 6th of December was sponsored by the South African **Department of Cooperative** Governance and Traditional Affairs (COGTA) pioneering the asset based approach through an ABCD workshop to enhance the capacity of farmers in the food, herb and cannabis sectors. Sadi Motsuenyane addressed the delegates at the workshop stating that asset based development is about people who see themselves first capable as having skills and recognizing the self as an asset. This she said as she spoke on the guiding principles of ABCD stating that "there are six key principles the first one stating that there is no one who is useless everyone has a gift" adding that there is need to nurture the gifts and to find out what the passions and the gifts are and to live them out. On one of the rooms in the cannabis transformation corner there lives a standoff between the Employers and the Employees in conflicting policy. Privacy in use and grow of cannabis has been cleared off the gutters of government law enforcement agencies and yet they remain as a thick lining on the guts of the corporate monstrosity. The continued captivity of colleagues held under suspended regulation remains a suspense like room we walk into as we behold the dealings of cannabis in the work space.

Stanley Ngalanga a Human Resource Development specialist in the cooperate world and a friend of the cannabis plant spoke to CannaXpress on cannabis and the challenges in the work space stating that "whilst the general acceptance of cannabis as a recreational and medical window has brought in a fresh breeze, the door of stigma still remains locked in the work place and cannabis as a plant is still dressed the old uninformed policies in the boardrooms".

Cannabis activist and Rastafarian, Letty "Angel Fire" Mabaso from the Rastafari Community of South Africa (RCSA) holds a BTech degree in metallurgical engineering and said she used to work for one of the big mining companies and had to resign after she was forced to go for a drug test. "I cannot find work as an engineer because engineers are required to undergo a drug test every year and cannabis is one of those drugs they test you for," she said. "If they find you with cannabis in your blood, you are taken to a

classification of cannabis as a drug with a live unemployment state update indicating that "South Africa is one of the countries that are hardest hit by the covid pandemic, and as much as the government is making efforts to create jobs, not everyone can be employed; So the question is what will happen to those that the employment system cannot absorb? Whatever reasons maybe?" The voice of a mind quietly pondering on a future of legislative uncertainties as she states that "It is either you stop being a Rasta, using cannabis, or you beg for work which unfortunately, I cannot do how do I dispose my spirituality just to work for somebody?"

The fire brand concluded as she stated that "this all emanates from limited understanding enforced by capitalists that marijuana is a drug it is not a drug but a herb that is natural, and I don't think a herb can be overdosed, only drugs can. We want marijuana to be taken out from the drug category. We are appealing to government to remove this classification because marijuana is a herb, this is a plant, not a drug. Drugs cannot be planted but are prepared in the laboratory".

Such are the rooms in the unwinding of a framework to accommodate the unravelling of a green machine that carries in its wings a revolution to life as was known for many industries. We are at the doors to a society that will in the few days grasp the full manifestation of the economy in cannabis on all its fronts. If the deal between Tyson and the Malawi agriculture ministry blooms it is said to be facilitated by the United States Cannabis Association (USCA) with the primary aim at roping in cannabis investors and potential biters into the Malawi Gold cake. MACSAs Executive Board Secretary, Wuezile Mgidlana shared his sentiments with *CannaXpress* stating that the deal could mean "the country could be having a challenge internally on the communities that their cannabis is growing in terms of not being able to know its origin and possibly with less knowledge into the potential that cannabis is holding for the people of Malawi". Duncan Nyirenda welcomed the decision to rope in Iron Mike stating that "the world is becoming a global

village who else wants to take the crown on cannabis and Malawi, Big up to Iron Mike". The gesture was however met with some resistance from Malawi as on Non-Profit Organisations spoke on reservations on the approach sighting a 1992 sexual assault conviction of Mike as the point of objection one wonders how twenty years later the Tyson2.0 still manages to block those jabs forwarded at the man, but as he states in his socials "a mind that is still as sharp as these hands" can make big things show up ahead.

Western pharmaceutical industries influence on local dagga production

Southern Africa ganja block overview Tulani Ngwenya

Which high hopes staked over Africa's dagga cultivation and its export, new fears loom over the extent of influence western pharmaceutical industries have on Africa's new and old businesses. Dagga optimism engulfing Southern Africa follows legalization of the plant's cultivation for medical and other scientific purposes.

Sibusiso Xaba, who is an investment banker and co-founder of the ACA Group, an advisory firm focused on the Africa cannabis market, has confessed that the southern Africa region "is one of the best places in the world to grow all types of cannabis".

This was also greeted with an influx of foreign investors from the global north taking keen interest in local dagga production processes.

In September 2021, the Zimbabwe Investment and Development Agency (ZIDA) said, "We have licensed 57 investors for medicinal cannabis production from Germany, Switzerland, Canada and as well some local players". "Companies have been licensed for cultivation and processing of medicinal cannabis and they own 100% of their investment," the agency added. Silas Howarth, the Cannabis Expo director pointed out that, "Global cannabis companies have also woken up to the reality that Southern Africa has the potential to supply the world with quality cannabis and cannabis products at competitive prices, and are pouring millions of dollars into cannabis projects in South Africa." Schütz referred to international

medicinal cannabis crowd-growing platform JuicyFields which is expanding its presence and operations in South Africa by connecting individual investors with licensed producers and distributors.

Globally medicinal cannabis industry is expected to reach a \$68 billion growth by the year 2027.

Southern Africa - South Africa, Zimbabwe, Lesotho, Morocco, Malawi, Ghana, eSwatini, and Zambia are pressing to get a share of this market with Prohibition Partners, projecting Africa's contribution to legal marijuana to hit a \$7.1 billion mark by 2023. It is clear that Africa stands to benefit from its global relationships with western pharmaceutical companies that have taken interest to invest and develop dagga cultivation, and production for medicinal and other scientific purposes in the region. Some of the big players in this space include Canopy Growth Corporation, GW Pharmaceuticals Plc, Aurora Cannabis Inc, Aphria Inc, MedReleaf Corporation, Insys Therapeutics Inc, CanniMed Therapeutics Inc, Cara Therapeutics Inc and United Cannabis Corporation. Most of these companies have established operations across

several continents.

Canadian-based Canopy Growth holds licenses for cultivation and production in Europe (Denmark) and South America (Colombia) (having recently exited operations in South Africa and Lesotho), with access to more cannabis markets via joint ventures and partnerships across the world.

Along with economic structural changes in order to accommodate the *green gold*, governments have created enabling environments for multi-million dollar deals to be sealed.

Stephen Kafeero revealed, "On June 3, Goodleaf, which has become one of South Africa's pioneer commercial cannabis brands, merged with Highlands Investments from neighbouring Lesotho, in a deal valued at about \$45.2 million." Prior to that in March 2021, Lesotho's MG Health, a licensed cultivator and manufacturer of pharmaceutical-grade cannabis extracts and products, became the first Africa-based cannabis firm to earn the much coveted EU Good Manufacturing Practices (GMP) certification which implies that the company can make deals in the European Union market. Researchers, Marta Rychert, Machel Anthony Emanuel & Chris Wilkins summarize GMP guidelines as "minimum requirements a manufacturer or producer must meet to ensure products are safe and of a consistent high quality. They are used to control the licensing for sale of food and pharmaceutical and medical products." Sibusiso Xaba has said that, "Medical cannabis is regulated to similar

standards as pharmaceuticals especially in Europe. Cultivation, processing, extraction, formulation requires rigorous thresholds of consumers safety. That requires a broad range of skills that we still need to develop at scale across Africa."

The role of western pharmaceutical companies in local cannabis production includes certification of seed, cultivation varieties, safety and processing.

Commenting on the influence of big cannabis business in Africa's production, Xaba said the legal cannabis cultivation comes with huge barriers to entry due to massive upfront investments, expensive-to-acquire licensing and need for technical experience across fields like agronomy, quality assessments and security. However, Xaba noted that "there is a skills transfer process that takes place and local growers, processors and operations learn how to run a local facility to international standards, something that is desperately needed if Africa is to compete at an international level." Despite having a rich a rich traditional, artisanal and underground history of cultivating and using cannabis, local producers need commercial expertise from global investors like Canopy Growth Corporation whose presence in Lesotho and other Southern African countries serves the purpose of transferring medical cannabis skills and standards to locals. Xaba argues that it is impractical for local citizens to do away with foreign expertise for now if we are to go legal, commercial and international. Lesotho Member of Parliament, Sam Rapapa from Mapoteng, a constituency where illegal cannabis production is rife, revealed that growing cannabis on a small scale is still criminal except for a few licensed growers. The 2008 Drugs of Abuse Act silences illegal underground producers by requiring them to operate under a license from the Ministry of Health. Putting pre-existing growers, these regulations came only recently due to the ever increasing interest by international companies. Lesotho small scale growers, who have been

impossible in your garden" explained Sadilek. Explanation by Sadilek is consistent with Xaba's: "Medical cannabis is regulated to similar standards as pharmaceuticals especially in Europe. Cultivation, processing, extraction, formulation requires rigorous thresholds of consumers safety. That requires a broad range of skills that we still need to develop at scale across Africa." In a research study, entitled, "Turning cannabis into cash: agrarian change and Lesotho's evolving experience", Bloomer (2019) identified "strong colonial overtones" and warned against the "takeover of the [cannabis] market by large corporations". However, foreign investment in budding cannabis markets of Southern Africa comes with the much needed capital to kick-start formal production and for research and infrastructural development. This was suggested by Abrol, Prajapati, Singh in their 2017 research paper, "Globalization of the Indian pharmaceutical industry: *implications for innovation*" who stated that foreign investment and knowledge transfer are attractive aspects in the medicinal cannabis sector, where production of cannabis for the export market must be in compliance with standards for international trade. After realising this reality, the Zimbabwean government chose to give back to its people by promoting local beneficiation, skill transfer and development of the local pharmaceutical industry. This the government did by permitting the establishment of the Cannabis Green Fund.

The Green Fund will be financed from the 20% share of the medicinal cannabis levy. The 20% share shall be used to implement, monitor and evaluate medical cannabis projects. Researchers, Marta Rychert, Machel Anthony Emanuel & Chris Wilkins, in their 2021 journal, **Globalization and Health** concluded: "While foreign investment has facilitated the commercialisation of the cannabis sector in Jamaica, regulatory measures are also needed to protect the domestic industry and support the transition of smallscale illegal cultivators to the legal regime. Foreign investments may alter the economic, social and political determinants of health in transitioning from illegal to legal cannabis market economy."

In Zimbabwe for instance, the Ministry of Lands works with the cannabis investment agency together with the Medicines Control Authority of Zimbabwe to ensure that the quality of the seeds imported meet regulatory requirements. What this effectively means is that cannabis production processes associated with global trade are heavily regulated in accordance with western standards which is likely to trump upon traditional standards and skills.

Tomas Sadilek, director of governmental affairs from the International Cannabis and Cannabinoids Institute, explained that selling local, small scale growers' cannabis into the international market would be almost impossible. He added that the need for consistency of strains is a necessity that could not be compromised when it comes to medicinal cannabis. "The problem is when you are talking about medical cannabis, you have to create an environment where you are 100 percent sure of what you are growing, and that's


